A replacement part assumes the remaining warranty of the original part or SIX (6) MONTHS from the date of replacement, whichever provides longer coverage for you. When a part is exchanged, any replacement item becomes your property and the replaced item becomes the property of Bio-Tek Services, Inc. When a refund is given, the part for which the refund is provided becomes the property of Bio-Tek Services, Inc
